II. CHARGES AND SPECIFICATIONS

10. CHARGE I: VIOLATION OF THE UCMJ, ARTICLE 92.


SPECIFICATION 1: In that Captain Christopher M. Beiring, US Army, who knew or should have known of his duties at or near Bagram Airfield, Afghanistan, between on or about 1 June 2002 and on or about 1 March 2003, was derelict in the performance of those duties in that he by culpable inefficiency failed to train and supervise the company under his command regarding the legal use of force and approved tactics, techniques, and procedures in detainee operations, as it was his duty to do.

SPECIFICATION 2: In that Captain Christopher M. Beiring, US Army, who knew of his duties at or near Bagram Airfield, Afghanistan, between on or about 4 December 2002 and on or about 10 December 2002, was derelict in the performance of those duties in that he willfully failed to take corrective and preventive actions directed by his Military Police superior and his legal advisor following the death of a detainee in the facility operated by his company, as it was his duty to do.

CHARGE II: VIOLATION OF THE UCMJ, ARTICLE 107.

SPECIFICATION: In that Captain Christopher M. Beiring, US Army, did at or near Bagram Airfield, Afghanistan, on or about 26 December 2002, with intent to deceive, make to an investigating officer, Colonel Joseph G. Nesbitt, an official statement, to wit: That the Soldiers of his unit conducted sustainment training after guard shifts, which statement was totally false, and was then known by the said Captain Christopher M. Beiring to be so false.
